

DOCTRINE OF THE UNITED STATES IN PROPHECY

- I. Introduction and preliminary considerations.
 - A. Since the Word of God is comprised of approximately 30% prophecy, it is only logical and consistent to subject this portion of the Scriptures to the same hermeneutic principles that govern all interpretation.
 1. Interpret literally, historically, and grammatically via the ICE hermeneutic.
 2. Recognize dispensational realities.
 3. Allow for symbolic and figurative language.
 4. Recognize the principle of double reference.
 5. Determine if prophecy is fulfilled, unfulfilled, or conditional.
 - B. For a believer living in the last days, orientation to the prophetic word is especially critical if one is to be properly acclimated to his time and place in history.
 - C. Daniel indicates that certain portions of the prophetic word would only be accurately understood as the time of the end approaches. Dan. 12:4
 - D. Like all other aspects of the Divine viewpoint, God reveals the truth to those that are positive and hides it from those that are negative. Matt. 11:25-26
 - E. Be aware that preconceived ideas and other factors such as personal opinions have the potential to blind the believer to the truth of doctrines he may not want to hear or accept. Jer. 32:1-5
 - F. Bear in mind that the Old Testament and New Testament prophets could only write in terms with which they were familiar; they had no frame of reference for modern technology, which we deal with on a daily basis.
 - G. The purpose of this doctrine is to demonstrate that the United States is the only entity that can reasonably fulfill all that is recorded about prophetic Babylon.
 - H. In that regard, Revelation 18 is critical to an accurate understanding since this places B_p in Daniel's 70th week.
 1. It has long been a part of orthodox and conservative interpretation to recognize that the events of Daniel's 70th week are recorded in Revelation 6-19.
 2. Further, the Old Testament passages found in Isaiah 13,21,47 and Jeremiah 50,51 are so obviously referenced in Revelation 18 that no intellectually honest interpreter could overlook that fact .
 3. It is these Old Testament prophecies that allow us to provide the detail that makes an accurate identification of the most affluent and powerful nation in view.
- II. The uses of the term Babylon in the Word of God.
 - A. The term Babylon is the Hebrew word בָּבֶל (bāḇel). The Akkadian term, as well as the related Sumerian term, seems to be derived from *bablani*, which means **the gate of the gods**.
 - B. The Hebrew term is found in conjunction with the verb בָּלַל (balal), a verb that means to mix, mingle together, or confuse. Gen. 11:9
 - C. It is widely recognized that this involves a play on words that denigrates the term **gate of the gods** by applying the term **confusion** to it.
 - D. The term is used at least six ways in the Bible.
 1. The first is found in the tower of Babel incident. Gen. 11:1-9

2. Secondly, it is used to refer to the historical kingdom of Babylon. Isa. 39:3 (B_H)
 3. Next, it is used to denote the city of Babylon. Dan. 4:29
 4. It is applied to the final form of the mother/son cult, religious Babylon. Rev. 17 (B_R)
 5. It is also used as a term for prophetic/economic Babylon. Isa. 13:19; Jere. 50:13; Rev. 18 (B_P)
 6. Finally, Peter uses it as a code name for Rome. IPet. 5:13
- E. The interpreter must first determine which Babylon is in view as he studies and make certain that he maintains the distinction between these entities.
- F. For instance, one must distinguish between B_R in Revelation 17 and B_P in Revelation 18.
1. They are different in designation. Rev. 17:5, 18:2
 2. They are different as to destroyers. Rev. 17:16, 18:6; Jer. 51:27-28
 3. They are different in direct context. Rev. 18:1
 4. They are different as to world reaction to their destruction. Rev. 18:9,11,15
 5. There are no Old Testament allusions to B_R, but B_P is replete with allusions to Isaiah 13,21,47 and Jeremiah 50:51. Rev. 18:2,3,4,5,6,7,8
- G. One must also distinguish between B_H and B_P.
1. Historic Babylon was not turned into a desert without inhabitant; the kingdom was taken intact and continued to function normally. Dan. 5:30-6:1; Jer. 50:3, 51:26
 2. There was no command for God's people to exit B_H; there are numerous commands for God's people to exit B_P. Jer. 29:4-7; Jer. 50:8, 51:6; Rev. 18:4
 3. The enemies that conquered B_H came from the immediate east (Isa. 46:11), while the enemy that destroys B_P comes from the north. Jer. 50:9
 4. Historic Babylon was situated near a river in a desert; prophetic Babylon is located on many waters and will become a desert. Jer. 51:13, 50:12

III. Scriptural details that demand the identification of B_P with the United States.

- A. The nation is not one of the ancient nations of the world, but one that comes on the historical scene toward the end of human history. Jer. 50:12
- B. The nation is one that clearly has its historic roots in a mother country. Jer. 50:12
- C. Its inhabitants are not viewed specifically as indigenous peoples; it is described as a melting pot, comprised of people from many ethnic and national origins. Jer. 51:9,44
- D. B_P must exist contemporaneously with other prophetic entities such as Russia, Great Britain, the kings of the East, the Revived Roman Empire, the Roman Catholic Church, and Israel. Dan. 7:1-7; Jer. 50:4-5
- E. It is a nation that was characterized by Divine grace and favor. Jer. 51:7
- F. However, that Divine blessing led to a nation that was characterized as an affluent, luxury society, which became the most massive importer of the world's goods in the last days. Isa. 47:1,5; Rev. 18:7,12-14
- G. In that regard, its populace became heavily involved in materialism greed and the pursuit of the details of life. Rev. 18:14
- H. Based on the massive number of imports, this nation made those that work in maritime professions exceedingly wealthy. Rev. 18:18-19
- I. The businessmen of B_P are described as the powerful leaders of the international community, exercising their authority and control over the world financial and political scene. Rev. 18:23
- J. Based on this fact, the nation became involved in international meddling, employing treachery and deceit to advance its unseen leadership. Rev. 18:9; Isa. 21:2

- K. Other nations less fortunate than Babylon have suffered extensively under the global capitalists, who are largely portrayed as being indifferent to the suffering they cause. Isa. 21:2,5; James 5:4,6; Rev. 18:13
- L. Babylon is a mecca for the entertainment industry and patron of the cultural arts. Rev. 18:22
- M. The destruction of B_P will initiate a worldwide hysteria; the destruction of that nation will wreak havoc in both the political and economic worlds. Rev. 18:9,11
- N. Babylon has a powerful northern enemy, which possesses the capability of destroying B_P in one hour of one day. Jer. 50:3,9
- O. In that regard, B_P is not destroyed via conventional means of warfare; it is attacked from a great distance and destroyed in a sudden and decisive fashion. Jer. 50:9; Rev. 18:8,10
- P. Identification of the codes used to portray these realities.
 1. Babylon the Great—The United States
 2. The Chaldeans—Anglo Saxon founders of America.
 3. The Medes—Historical enemies of the Chaldeans, modern Russia.
 4. Arrow—Nuclear tipped ICBM.
 5. Bow—Silos and launching pads for missiles.
 6. Fire—Thermonuclear warfare.
 7. Vapor of smoke—Result of nuclear devastation; fallout containing the vaporized remains of millions of people, animals, and structures.
 8. Your mother—The nation Great Britain, from which Babylon descended.
- Q. This body of detailed evidence mandates that the United States be identified as prophetic Babylon; no other nation can fulfill everything that is required by these details.

- IV. Documentation of America's descent into evil and the reasons for her destruction.
 - A. This nation, like all nations, was established by God, Who determined our **appointed times and the boundaries of our habitation**. Jer. 18:9; Acts 17:26
 - B. Based on the initial premises of Divine viewpoint upon which this nation was founded, America experienced unprecedented blessing from God, which resulted in tremendous prosperity. Jer. 51:7
 - C. However, the sad reality is that some people are not content merely with limited prosperity; there are those that have dreams of harnessing the prosperity of the world for themselves.
 - D. This reality led to change during the early part of the 20th century as America's money barons, such as J.P. Morgan, John D. Rockefeller, and Bernard Baruch began to link themselves with the European banking interests, which were largely dominated by the Rothschild family.
 - E. At the heart of their vision, these powers of financial capitalism had a far-reaching aim, which was nothing less than to create a world system of financial control in private hands.
 - F. The plan was simply to dominate the political system of each country and the economy of the world as a whole. *Carroll Quigley, Tragedy and Hope*
 - G. An early attempt to saddle the nation with a privately controlled central bank (Bank of the United States) was abolished by President Andrew Jackson, who declared, "*the bold effort the present bank has made to control the government, the distress it has wantonly produced...are but premonitions of the fate that awaits the American people should they be deluded into a perpetuation of this institution or the establishment of another like it.*"
 - H. However, through a series of manipulations, such men as Nelson Aldrich, Paul Warburg, and John Rockefeller among others, succeeded in establishing the Federal Reserve Bank by congressional act in December 1913.

- I. Congressman Charles Lindbergh Sr. was one of the most outspoken opponents of this and declared, *“This act establishes the most gigantic trust on earth...When the President signs this act the invisible government by the money power, proven to exist by the Money Trust investigation, will be legalized...”*
- J. Congressman Louis McFadden later added, *When the Federal Reserve Act was passed, the people of these United States did not perceive that a world banking system was being set up. A super-state controlled by international bankers and international industrialists acting together to enslave the world for their own pleasure.”*
- K. Our nation eventually came under the control of these ruthless monopolists who now had the power to manipulate the economy of the United States, illegally issue money, control the money supply, and artificially create periods of inflation and deflation at will.
- L. These same men from the Eastern Establishment formed the Council on Foreign Relations (CFR), through which they supplied a steady stream of individuals to occupy the highest ranking political offices in our nation.
- M. Through early 1988, fourteen secretaries of state, fourteen treasury secretaries, eleven defense secretaries, and scores of other federal department heads have been CFR members.
- N. Several men who later became Presidents of the United States were CFR members earlier in their political careers such as Eisenhower, John Kennedy, Richard Nixon and Jimmy Carter; although not a member, Bill Clinton was mentored by Carroll Quigley.
- O. This explains why the two-party system is an illusion; it pretends to offer the populace a choice, while maintaining CFR control no matter which party is in office.
- P. This has resulted in a situation in which our visible government is nothing more than a front for the invisible leadership (the international bankers and industrialists), who are attempting to establish an international system that they rule.
- Q. The true facts are almost beyond belief, but suffice it to say that these men have clandestinely supported world communism as part of their evil, causing untold suffering on a global scale. Isa. 14:4-6, 21:2
- R. These men have used our government to manipulate other governments, exploit the resources of developing nations, and further increase their wealth and power. James 5:1-6
- S. The citizens of the nation grew arrogant, came under the idolatry of greed, and were all too willing to allow this situation to continue. Jer. 50:38 **Her people act like madmen because of those idols they fear.** (NET)
- T. In addition to the international manipulation and global atrocities that these industrialists have sponsored, our nation has several other charges levied against it by the Lord.
 1. Anti-Semitism. Isa. 47:5-6; Jer. 50:6-8,11,33-34, 51:34-36
 2. Arrogance. Is. 47:7-8; Jer. 50:11,29; Rev. 18:7
 3. Idolatry, which is not only a trait of the greedy bankers, but of the covetous populace at large. Isa. 21:9; Jer. 50:2, 51:17-18
 4. Demonic activity, obviously based on the rejection of Divine principles. Rev. 18:2
 5. There is an explicit similarity between the destruction of the U.S. and the destruction of Sodom and Gomorrah, suggesting that the two have tolerated the same perversity. Isa. 13:19; Jer. 50:40
- U. Although adjusted communicators have sought to bring these facts to light, the sad reality is that many in our nation are not interested in the truth regarding our nation and its destiny. Jer. 51:5,9

- V. Part of our descent into evil has been fueled by the groundless and arrogant assumption that America cannot and will not fall.
 1. Jimmy Carter boldly stated, *“America will always come back”*, which unfortunately reflects the mindset of many Americans. Isa. 47:10
 2. Part of our evil has involved manipulation of various nations (allies and enemies alike) through the diplomatic process, which will not save the nation this time. Isa. 47:12-13
 3. Another aspect of our national arrogance is our confidence that we will be delivered by our “advanced technology”, including such things as SDI, and Star Wars. Jer. 51:53
 4. Since this country has never suffered a war on its own soil from an outside aggressor and has enjoyed past military successes, there are some who assume that the military will be able to protect the nation. Isa. 47:1; Jer. 50:23

V. Babylon’s enemy identified.

- A. Just as Babylon is used as a prophetic name for the United States, even so Babylon’s enemy is identified in a similar fashion as **the Medes**. Isa. 13:17; Jer. 51:11
- B. The Medes form the frame of reference since they were historically the enemies of Babylon, and ultimately took control of it. Dan. 5:25-31
- C. As pointed out previously, the historic Medes cannot be the same as the prophetic Medes since the former came from the east and the latter from the north. Isa. 46:11; Jer. 50:9
- D. In fact, the prophetic Medes are described as a powerful enemy from the farthest regions of the north. Jer. 50:3,9,26
- E. This nation actually commands a confederacy of satellite nations, which will participate in a limited way in the attack. Jer. 50:9, 51:27-28
- F. Although it was recognized that their kingdom was historically inferior to the kingdom of Babylon, the Medes eventually conquered it. Dan. 2:32,39
- G. The Medes were famous, along with the Elamites, for being some of the most outstanding archers of their time. Isa. 21:2; Jer. 50:9,14, 51:11
- H. With that frame of reference, it should be obvious that there are parallels between the fall of B_H and the fall of B_P.
- I. Just as B_H fell suddenly, apart from conventional warfare, without losses to the military of the Medes, even so B_P will suffer the same fate.
- J. The prophetic Medes are described as arrogant, cruel, and ruthless, which the leadership of any nation would have to be to instigate the devastating nuclear attack. Isa. 13:17-18; Jer. 50:42
- K. A quote from Russian military strategist Col. Sidorenko provides some insight as he says, *“Only the offensive leads to the attainment of victory over the enemy. As a type of combat, the offensive has incontestable advantages over the defense. The attacker has broad capabilities for launching surprise strikes, for the rapid exploitation of the results of nuclear attacks...”*
- L. As a recent (1999) article indicates, the former Soviet Union was well underway with ominous preparations, which have continued to escalate recently.

VI. The actual Soviet attack on the United States.

- A. God makes it quite clear that He is the force behind this attack; He is the ultimate planner, instigator, and administrator of the destruction. Isa. 13:17; Jer. 50:9,13,18,21,25

- B. The Russians are God's chosen instruments, picked to execute His burning indignation on our nation; He will actively bless them in their efforts. Isa. 13:3-5; Jer. 50:9
- C. The timing of their attack is placed just prior to the beginning of the Day of the Lord, which technically begins at the middle of Daniel's 70th week. Isa. 13:6,9
- D. This event is foretold in the Word of God, will be announced by two separate angels at the outset of Daniel's 70th week, and will be proclaimed by the 144,000 Jews and other adjusted communicators. Isa. 21:10; Jer. 50:2; Rev. 14:8, 18:2
- E. The destruction will be announced for some three years before it actually occurs, possibly in the first month of the third year. Jer. 51:46
- F. During this time, those that have been warned will have the opportunity to depart the U.S. and return to the land of their ethnic origin. Isa. 13:14; Jer. 51:9,44
- G. Adjusted Jews are to set the example and lead the exodus out of the United States. Jer. 50:8, 51:50
- H. Those that fail to separate geographically from the U.S. will suffer the fate of a quick or slow death in the attack or in the fallout from the attack.
- I. The nature of their attack.
 1. It will be thoroughly investigated and meticulously planned, assuring the enemies of Babylon complete success. Isa. 13:2; Jer. 51:12
 2. It will take every segment of our society by complete surprise, the leadership of the government and the citizens alike. Isa. 13:8, 47:9,11; Jer. 50:24
 3. The attack will not come from one geographic region; Babylon will be completely surrounded by the weapons of her destruction. Jer. 50:14,29
 4. The attack will not take an extended period of time; it will be swift, coming in the course of one hour of one day. Isa. 47:9; Rev. 18:10,17
 5. The attack will be ruthless, the arrows will spare no one and there will be no mercy on that day. Isa. 13:15-16, 47:3
- J. The results of the Soviet attack.
 1. The strategic nuclear arsenal of the Soviet Union is vast and powerful, being comprised of over 11,000 strategic nuclear warheads mounted on intercontinental ballistic missiles (ICBMs), submarine launched ballistic missiles (SLBMs), and strategic bombers.
 2. This massive arsenal will apparently be completely depleted in the attack. Jer. 50:14
Shoot all your arrows at her! Don't hold any of them back! (NET)
 3. The entire military force resident within the nation will be completely destroyed. Jer. 51:3
 4. The civilian population at that time will be reduced to zero. Jer. 50:3, 51:29,37
 5. In the short term, all animal life will be destroyed or migrate out of the nation; only desert animals and scavengers will ever return. Isa. 13:21-22; Jer. 50:3,39, 51:37
 6. Babylon will never be inhabited again, and no human will ever attempt to approach this nuclear desert. Isa. 13:20; Jer. 50:40, 51:43
 7. The mushroom cloud, full of debris and the vaporized remains of Babylon's inhabitants, will be of sufficient size as to impact the functions of the sun and moon. Joel 2:30-31; Rev. 6:12
 8. The continuing effects of the destruction will be felt throughout the final half of Daniel's 70th week, and are the subject of the first four trumpets. Rev. 8:7-12

VII. The national and global response to the Soviet attack.

- A. Due to the unprecedented peace movement and the fact that Americans are either oblivious to the Soviet threat or do not take it seriously, the nation is completely unprepared. IThess. 5:3
- B. We have historically trusted in a number of things to provide deliverance from our enemies; although successful to this point, they will not deliver the nation from the coming destruction.
 - 1. We have been engaged in diplomacy from the earliest times of our history, creating alliances that include the League of Nations, NATO, and participation in the UN. Isa. 47:12,15
 - 2. America has become a nation that is filled with political counselors and prognosticators; however, Safire, Limbaugh, O'Reilly, Franken, and Maher will not be of any help. Isa. 47:13
 - 3. The political and diplomatic intimidation we have manifested through our history will not be effective in this case. Isa. 47:12
 - 4. Our reliance on education, technology, computers, and space technology will not be able to deliver the nation. Isa. 47:10; Jer. 51:17-18, 51:53
 - 5. The nation manifests an arrogance that is based on its historic invincibility. Isa. 47:8,10
- C. The news of the attack will come to our national leader, who will be unable to respond to the threat due to overpowering fear. Jer. 50:43
- D. The impotence attributed to the president will also strike the military forces stationed in this nation. Jer. 51:30,32
 - 1. This nation has effectively disarmed itself via its participation in treaties with our enemies, which are also called agreements, covenants, charters, protocols, pacts, and accords. Jer. 50:15
 - 2. The lack of leadership in the White House will ensure the lack of a military response, even if the military was prepared.
- E. The general populace will exhibit the same panic as the military leadership of the nation when they recognize what is happening. Isa. 13:6-8
- F. Those that do not die in the initial devastating attack will live to see the nuclear fire destroy their loved ones, homes, and nation. Isa. 13:8,15-16
- G. Global responses will include the following:
 - 1. The Soviet response will be ecstatic jubilation. Jer. 51:14
 - 2. The response of world political leaders will be one of mourning and depression. Rev. 18:9
 - 3. World economic communities will exhibit mass hysteria. Rev. 18:11,15,17
 - 4. Adjusted believers are commanded to avoid these human viewpoint responses and rejoice in the destruction of Babylon. Jer. 51:48; Rev. 18:20

VIII. Various other terms and codes applied to the Babylon and their significance.

- A. Several names are applied to prophetic Babylon, each having its own particular nuance, and each providing insight into God's view of the United States.
- B. The U.S. is seen as prophetic Edom. Jer. 49:17-22; Obad. 1:1ff
 - 1. A careful comparison of the destruction of Edom with the destruction of Babylon indicates that they are one and the same. Jer. 49:17-22, 50:40,43-46
 - 2. That this cannot refer to historic Edom or to the region of Edom is documented by the fact that the region is currently inhabited and will become the refuge of adjusted believers during Daniel's 70th week. Dan. 11:41; Rev. 12:6

3. Edom, which is the Hebrew term אֶדוֹם (‘edom), became the name of Esau, the negative unbelieving brother of Jacob. Gen. 25:30; Mal. 1:2-4
 4. This is very fitting name for the United States since we, like Esau of old, have rejected our spiritual heritage and sold our birthright for the pursuit of physical gratification Heb. 12:16
 5. The land of Edom is comprised of rugged mountains, which form a sort of natural fortress and make the land **appear to be invincible**. Obad. 3-4
 6. Likewise, our position in the western hemisphere and our reliance on our military have succeeded in making the nation largely feel invincible.
 7. The primary point in the denunciation of Edom was the fact that the Edomites did not treat the Jews properly. Obad. 10-15
 8. Edom then serves as the frame of reference for a nation in the last days that betrayed the trust of the Jews (Obad 10-15), occupied a seemingly invincible position (Obad 3-4), became arrogant against the Lord (Obad. 3), trusted in human viewpoint wisdom (Obad. 8-9), and is destroyed by God.
 9. The treachery by which prophetic Edom operated will be visited upon it, as the nation will be deceived and destroyed by those it trusted. Obad. 7
- C. The names of the gods of Babylon serve to point out the character of the nation, as well as its activities.
1. **Bel**, the confuser or confounder, was symbolized as a two-faced deity, possessing a club with which he would subdue others. Jer. 50:2
 2. **Marduk/Merodach**, the great rebel, was the ringleader in the initial apostasy at Babel, and became the source of world unrest. Jer. 50:2
 3. It has been suggested that the word is derived from the Hebrew מָרַד (maradh—to revolt or rebel), and very much characterizes our rebellion against the Lord, as the nation rejects the Divine institutions and pursues vanity.
 4. The Divine irony is that the confuser will be confused in the end; the rebel will suffer rebellion from those she has supported.
 5. **Merathaim**, which means double rebellion, is used to teach that we have rebelled mightily against God in our rejection of the His laws and doctrines. Jer. 50:21
 6. **Pekod**, which means punishment, is employed to denote God’s intention to utterly destroy the nation. Jer. 50:21
 7. **Leb-kamai**, which means heart rising up, is a term that illustrates the arrogance of soul that has come to characterize Babylon. Jer. 51:1
 8. **Sheshak**, which is an atbash (a reversal of the letters of the alphabet in which the first letter is used for the last letter and so on), indicates that things have become backward in Babylon, the land of confusion. Jer. 51:41
- D. The regular comparisons to **Sodom and Gomorrah** are also designed to indicate what God thinks of the nation under evil.
1. Both were the most prosperous economic regions of their time. Gen. 13:10
 2. Both declined into evil despite God’s blessing.
 3. Both tolerated the abomination of homosexuality. Gen. 13:13, 18:20, 19:4-5
 4. The Lord is the agent of both destructions. Gen. 18:17, 19:23-25
 5. The primary instrument of destruction is fire. Gen. 19:24; Isa. 13:8, 47:14; Jer. 50:32, 51:30

6. Like the inhabitants of Sodom and the cities of the plain, the inhabitants of the U.S. regard their destruction as unthinkable. Gen. 19:14
7. The environment and surrounding area was devastated and the population was reduced to zero. Gen. 19:25
8. Neither region will be inhabited by men again. Jer. 50:40
9. Believers were notified prior to the destruction to vacate the region; Abraham was made aware of the impending disaster by revelation even though he was not a resident of Sodom. Gen. 18:17
10. Lot was likewise warned to get out before it was too late. Gen. 19:12

IX. Applications of this doctrine to those that reside in America.

A. Believers that live before the rapture should:

1. Recognize that this event does not occur until the third year of Daniel's 70th week. Jer. 51:46
2. Not succumb to fear based on current events or sensational stories from Russia or the Middle East.
3. Not fall into the plausible trap that this horrific event can be averted by any means; this prophecy is not conditional. Isa. 13:6, 21:10, 47:9,11
4. Avoid any type of human viewpoint solutions to the problems that confront this nation.
 - a. Retreating from society, building a compound, and storing up food, guns, and ammunition. ICor. 7:24; James 5:7-9
 - b. Pursuing political action agendas in the hope that a political solution will change or deliver this nation. Isa. 47:12
 - c. Praying for God to change His mind.
 - d. Avoid the militia mentality; do not become engaged in seditious or terrorist types of activities. Rom. 13:1ff
5. Recognize that the only means of recovery is through acceptance and orientation to the sound doctrine we teach and the nation at large rejects. Prov. 1:20-31
6. Avoid the primary malaise that has become the norm for the majority of those in Christendom—the lukewarm syndrome. Rev. 3:14ff
7. Make certain to avoid anyone that is involved in setting dates. Matt. 24:36
8. Fastidiously seeking to avoid the primary sin of Babylon—materialism/monetary lust. James 5:1-6; Rev. 18:11-14
9. Continue to pray for those in the establishment chain of command so we may have an environment that allows us to pursue the intake and application of doctrine. ITim. 2:1-2
10. Encourage other believers with respect to the importance of the intake and application of doctrine. Heb. 10:25
